IN MEMORIAM

The Chapter regrets to announce the passing of Robert C. Dowsett 5T0 earlier this year.

Br. Dowsett was born on June 27, 1929 and attended the University of Toronto Schools until 1946. At UTS, Robert captained the football team and met his lifelong friends, Br. John Evans 5T0 and Br. Joe McArthur 5T0.

The trio pledged Alpha Delta Phi together in the fall of 1946 and would spend many Monday evenings at Chapter meetings over the ensuing years. Br. Dowsett



graduated from the University in 1950 with a BA Honours in Mathematics and Physics.

Immediately upon graduation he began his career at Crown Life Insurance. In 1954, he became the youngest person in Canada to achieve a designation in Actuarial Sciences. He progressed through the company, becoming President of Crown Life in 1971. He was a founding member of the Canadian Institute of Actuaries, serving as President in 1973-1974.

Br. Dowsett's impact on his community was significant. He was a tireless volunteer and fundraiser; he often said his greatest achievement was giving back to others. He served on many non-profit boards including The Donwood Institute, The Council for Canadian Unity, Addiction Research Foundation, UTS, U of T, McMichael Art Collection and The CAMH Foundation. In 2002, in honour of the University's 175th Anniversary, Robert was named to the "Group of 175" – 175 of the most influential graduates of the University of Toronto.

We are very saddened to announce the tragic passing of Michael Plonka 0T4 on September 4th, 2018.

Michael graduated from the University in 2004 from the Faculty of Engineering. He was a dedicated Brother, serving on

the House Company Board from 2010-2015, most recently as President of Board from 2013-15.

He will be missed dearly by all, most especially his Brothers in Alpha Delta Phi.

John Pollock 5T9 was a recipient of the University of Waterloo's 60th Anniversary Alumni Award. Br. Pollock has served on the Board at UW and donated more than \$500,000 to the school. He also served as Chancellor of Wilfrid Laurier University from 2008 to 2011.

125 YEARS IN TORONTO

In late January of 1893, the first meeting of the Toronto Affiliate of Alpha Delta Phi was held in Oddfellows Hall at the corner of Yonge and College. Over the next six months, delegates from the International would conduct visits to observe weekly meetings and literary events. Finally, on June 10th, 1893, 3 professors, 7 graduates, and 10 undergraduates from the University of Toronto were initiated into the Alpha Delta Phi by the Columbia Chapter. The first Chapter meeting was held three days later at the law office of Messrs. Macdonnell & Scott.

Despite following Zeta Psi and Kappa Alpha as the third "Greek letter" society at the University of Toronto, Alpha Delta Phi was the first organization to provide housing and furnish a property for its members. At present, we know of at least five properties that acted as the official "Chapter House" since 1893.

Over the ensuing one-and-a-quarter century, our Chapter has left a distinguished mark on not only the University, but on our city and our country. With esteemed Brothers advancing in fields of finance, industry, academia, medicine, politics, law and the arts, the Toronto Chapter has indubitably become an ideal medium through which ambitious men can further their moral, social, and intellectual pursuits.
